A Primer on 501c3

The CCA board is considering applying for 501c3 status because it would help ensure sustainability of the organization for the future. Section 501(c)(3) is the portion of the US Internal Revenue Code that allows for federal tax exemption of nonprofit organizations. Currently, the CCA is a not-for-profit corporation, but is not a 501c3 corporation. The CCA appears to qualify for 501c3 status without changing its current mission.

The Benefits of 501c3 Status There are a number of benefits to having 501c3 status. First, 501c3 organizations are exempt from federal income taxes. Also, 501c3 corporations are eligible for direct grants from foundations and other charities. This would allow CCA to apply for grants to further our goals and fund our activities. In addition, 501c3 status means that private donations are tax-deductible.

Requirements to Become Exempt Under 501c3 According to IRS, to qualify for this exemption the corporation must be organized for one or more of the following purposes: religious, charitable, scientific, testing for public safety, literary, educational, fostering national or international amateur sports competition or the prevention of cruelty to children or animals. The CCA would fall under the charitable category. The IRS states: "Some examples of this type of organization are those organized for relief of the poor, the distressed, or the underprivileged, advancement of religion, advancement of education or science, erection or maintenance of public buildings, monuments, or works, lessening the

burdens of government, lessening of neighborhood tensions, elimination of prejudice and discrimination, defense of human and civil rights secured by law, and combating community deterioration and juvenile delinquency." Each of the activities undertaken by the CCA fall into one or more of these categories. For example, our Beautification Committee work, as well as our Safety & Security Committee and Community Development Committee combats community deterioration. Our Programming Committee coordinates free or low-cost family events throughout the year that provides relief of the poor, the distressed, or the underprivileged. We lessen the burdens of government by providing a mechanism for government entities to connect with community stakeholders and by educating the community about government activities that affect our community.

The Costs and Limitations of 501c3 Status There are some restrictions that come with 501c3. There is an application process fee and there is an annual report due to the IRS. 501c3 corporations are prohibited from making payments to 'insiders' (such as members or board members) unless they are reasonable and are for specific services or goods. 501c3 organizations are prohibited from supporting or opposing any candidate running for public office. 501c3 organizations are allowed to lobby, but lobbying cannot exceed 20% of

expenditures. (Lobbying is narrowly defined for this purpose as communication with legislative or government official about a specific legislative proposal and stating a position for or against the proposal). Other communication with government officials, conducting research on issues, recommending solutions to problems are permissible and are not limited.

For Consideration Based on the CCA's activities and goals, the limitations imposed by 501c3 are consistent with CCA practice, so they would not impact our activities and the benefits could be substantial. Of course, when the IRS reviews our application, it may not agree that our purposes meet their definition of "charitable". In that case, the application would be denied. If it is approved, we can begin looking for grants to fund our activities. If, in the future, the CCA wishes to undertake an activity that does not meet the IRS definition of "charitable" (like starting a PAC, or lobbying for a particular candidate) we would need to amend our bylaws, give up the 501c3 designation and, possibly, terminate any grant program that requires we do so.

The CCA will soon be proposing changes to our Bylaws and Certificate of Incorporation. Some of the proposed changes are necessary for a 501c3 application, but we are not proposing anything that would change the mission of the CCA. These changes do not, in and of themselves, require that we apply for 501c3 status. That is a separate issue and decision.



**Update: Molly Clifford
Northwest City Council Member**

October was Fire Prevention Month and most of you know that fire safety and prevention are near and dear to my heart, both as a former administrator for the Rochester Fire Department and as a current fire-safety educator. Accordingly, I strongly encourage all of you to make fire prevention a priority this month and every month!

This is important because unintentional injuries, including those resulting from fires, are the leading causes of death for people under the age of 44 and over the age of 65. No one thinks that “accidents” will happen to them; unfortunately, they do. Taking some simple steps in preventing them should become part of our daily habits, like exercising and eating appropriately!

First, please make sure you have working smoke and carbon monoxide alarms; at least one on every floor. Smoke alarms are recommended inside every sleeping area and in the hallways outside bedrooms because, while most fires happen during the day, most fatal fires happen at night. You need to make sure that you and your family members can hear the alarms immediately (remember our older family members’ hearing may be impaired, especially if they take

hearing aids out at night). Additionally, please test smoke and CO2 alarms once a month since they are not failsafe; even long-lasting batteries and new alarms can malfunction.

Secondly, please take time to plan and practice your exit drill (complete with a meeting place) twice a year. Most injuries from fires happen when people are escaping. We have a tendency to think that we know our homes well and will know what to do if a fire breaks out. However, the stress of waking up to a fire in the middle of the night, disoriented and worrying about children, parents, pets, belongings, etc. can stress even the most competent individuals!

I am on the Board of Prevention 1st, a local non-profit that focuses on fire safety and injury prevention. Visit www.prevention1st.org for more tips!
